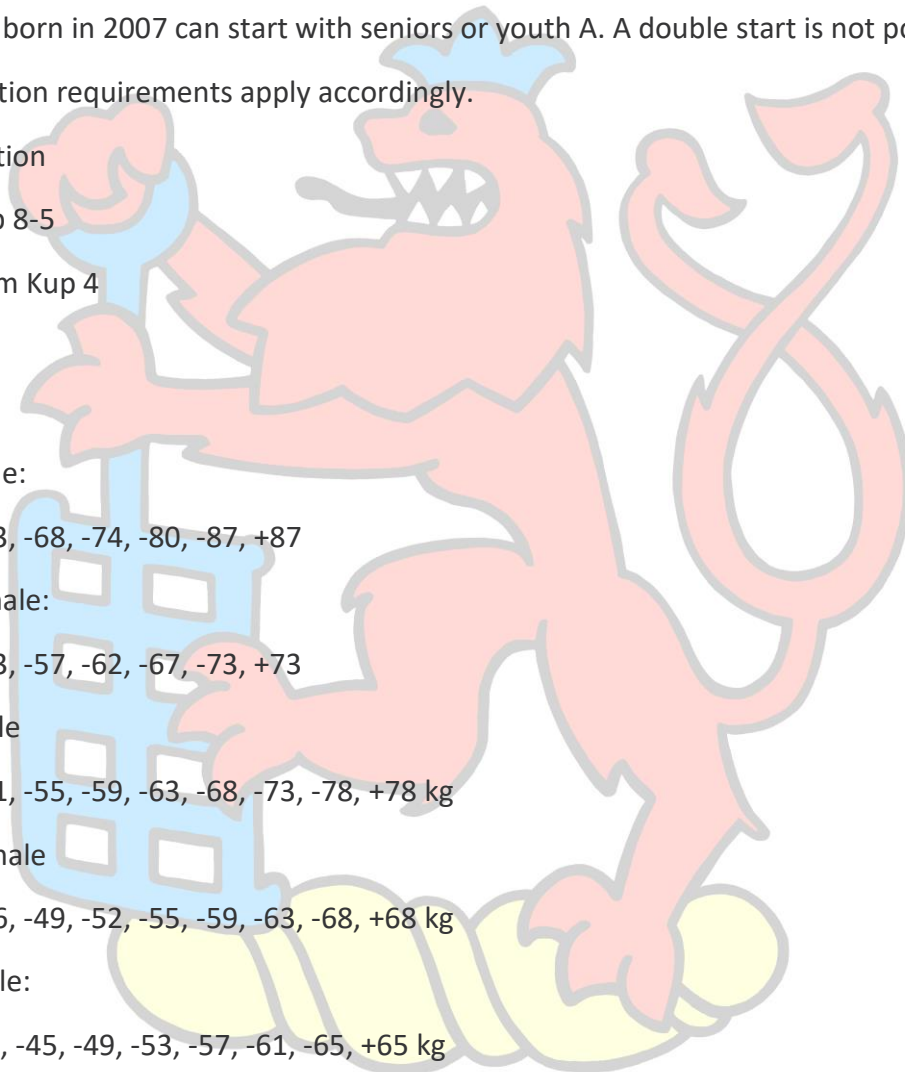

## 5. Weight-IN/registration

5.1 Weight: The processing fee for a weight class change is 10€. The scales used are binding.

5.2 Identification: According to the rules of the German Taekwondo Union e.V., all participants must prove their identity by presenting their valid ID card, passport or child ID card.

Each club receives the ID cards for its athletes from the registration office. These ID cards contain ALL competition-relevant data such as surname, first name, weight class, gender and performance class. This data MUST be controlled by the competitor or coach. Any changes must then be indicated on the scale. Once the scale is complete, NO changes will be made. Athletes who have been registered in the wrong class and who have not reported this by weight-in cannot participate in the competition.

## 6. Rules

### 6.1 Miscellaneous:

Any ambiguities arising from the WOT will be clarified by the competition management. Only the approved coach can protest at competitions. This must be done in writing after the fight is over. Organizers and organizers accept no liability for damage to property or personal injury. By handing in the start card/registration, the club assures that its registered underage athletes have a declaration of consent from a parent or legal guardian to participate in the event. The organizer thus delegates the responsibility for the starting authorization or participation of the underage athletes to their home clubs. The registering club must ensure that the declaration of consent is available during the event and that it can be presented at the request of the organizer. A lack of declaration leads to disqualification or exclusion from the event. If a participant does not meet the criteria required for participation in the championship, he will be excluded from further participation. If a club does not meet the criteria for participation in the championship, the entire club will be excluded from further participation. The entry fee and all other costs incurred by the athlete/club and their companions and relatives will not be reimbursed. The statutes and

regulations of the DTU as well as the rules for full contact tournaments of the DTU and WT must be observed exceptions

require written confirmation from the competition director.

If there is only one athlete in a weight class on the day of the competition, he will automatically be placed in the next higher weight class.

Protest fee: 50 €

Liability: Organizers and organizers accept no liability for personal injury or damage to property. Everyone involved in this championship participates at their own risk. By registering, the clubs, the athletes and their legal guardians expressly agree to the disclaimer.

Supervisors: Two supervisors per club have free access. For clubs with more than 10 participants, three supervisors have free access. More than 3 supervisors are not permitted.

6.2 Trainers: The trainers are to be named in the registration with their name and date of birth. Only approved trainers (16 years and older) are allowed to coach.

6.3 Protective equipment: The competitions are carried out with DAEDO PSS vest and head protection, further protective equipment must be brought by the athlete, shin guards, forearm protection, groin protection, mouth protection (white or transparent), TKD hand protection. Bring sensor socks DAEDO with you. Handguards are mandatory.

6.4. Data protection: The Taekwondo Sportschule Wuppertal e.V

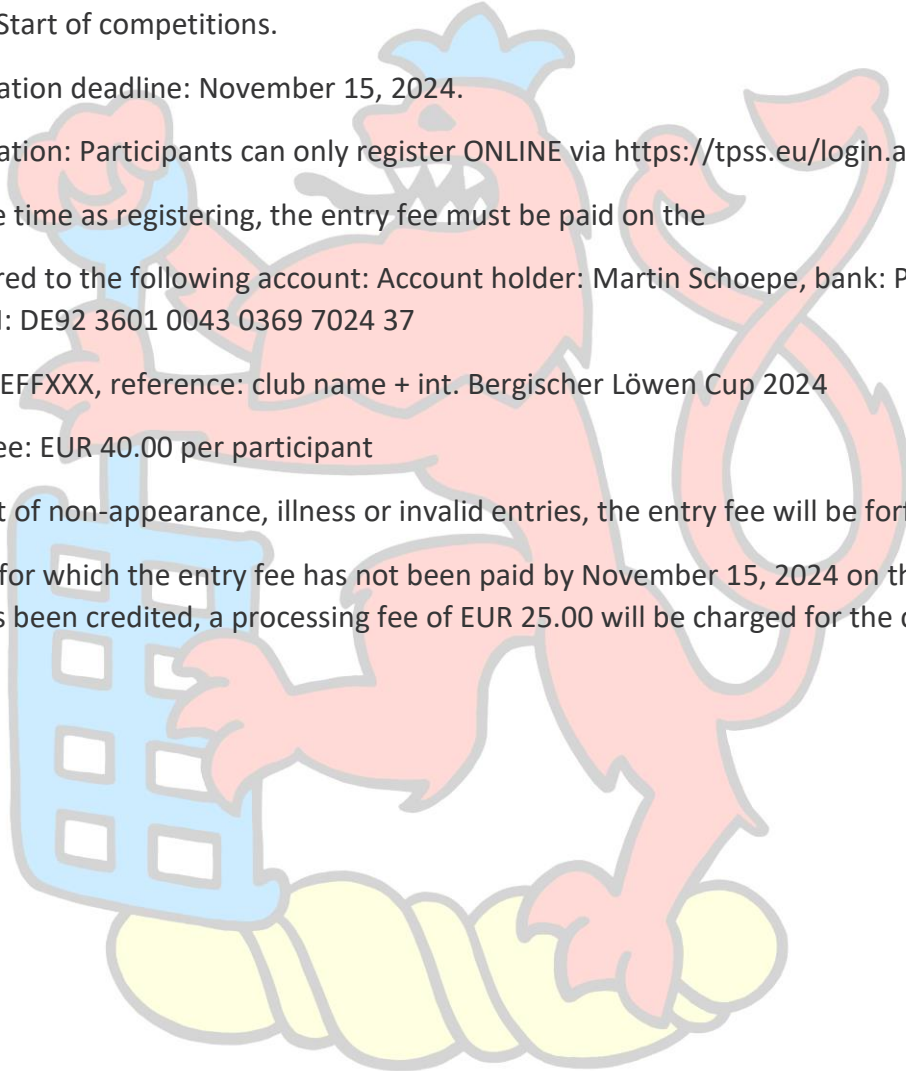
