## Participation requirements

All participants must present an official and valid photo ID at registration. Copies or screenshots will not be accepted! Athletes must be in proper health to take part at this event and have valid health insurance. Only athletes who are members of German Taekwondo Union (DTU), European Taekwondo Union (ETU) or World Taekwondo (WT) may participate. International athletes must prove membership via an ID from their national federation.

## Competition equipment

According to the rules & regulations of the German Taekwondo Union. Electronic protector and scoring system by Daedo (Gen. 3) will be used. Electronic foot protectors must be brought by athletes, but can be purchased on-site for 75 € or before via [www.daedo-gen3.de](http://www.daedo-gen3.de).

## Rules and regulations

**Rules:** The currently valid competition rules (WOZ) of the German Taekwondo Union (DTU) apply. Deviations or special rules regarding these competition rules require approval by the protest committee at the competition day.

**Competition method:** Single elimination, KO-System (Best of three)

**Eligibility:** All participants must be affiliated members of DTU, ETU or WT.

**Duration of contests:** Maybe shortened depending on the number of participants.

**Team ranking:** Can be determined in conclusion of individual results, as following:

7 points	1 <sup>st</sup> place
5 points	1 <sup>st</sup> place (uncontested)
4 points	2 <sup>nd</sup> place
1 point	3 <sup>rd</sup> place

Should two or more teams have the same amount of points, the result will be determined according to the number of gold, silver and bronze medals first. Afterwards according to the number of participants and thereafter according to more points in higher weight divisions.

**Awards:** Medals for places 1 - 3                      Individual awards  
Trophies for places 1 - 5                      Team awards

**Result publication:** All participants agree to publication of their name, club, weight class, nationality, and placement on the internet and/or in printed result lists.

**Protest:** Only an officially registered coach is allowed to protest immediately after the end of the contest. A protest fee needs to be paid for each protest immediately. The decision of protest committee chairman is final. (DTU- WOZ, Art. 19.1).

The protest committee with at least three members will be appointed by the competition manager (referee director and protest committee chairman) or his representative prior to the start of the competition.

For a certain number of athletes above mentioned coaches have free admission, but at maximum 6 coaches per club. The minimum age for a coach is 17 years and must wear a training suit with indoor shoes (light soles). A towel is required. Only coaches with a NWTU coach license are allowed to coach!

## Declaration of consent

All participants, who are minor (under legal age of 18 years) at the day of the tournament need a declaration of consent (NWTU template) signed by a legal guardian, which must be brought to the tournament and presented on request. Consent forms can be submitted prior to the tournament digitally at latest by **Friday, 06.06.2025 (23:59 PM)** exclusively as one PDF file to [n.kazkaz@nwtu.de](mailto:n.kazkaz@nwtu.de) (Fast Lane).

## Liability declaration

Every person participates at their own risk. With the registration, each contestant or their legal guardian agrees explicitly to the exclusion of liability. Promoter and organizer do not assume liability for any damage to persons or property!

## Directions to the venue

- From Cologne/Aachen: Autobahn **A 4** towards Olpe. **Exit No. 25 Gummersbach/Wiehl**, turn right towards **Gummersbach-Zentrum** onto the **B256** (approx. 5 km). Turn right onto Moltkestraße. The Eugen-Haas-Hall is located about 300 meters further on the left-hand side.
- From Olpe: Autobahn **A4** towards Cologne. **Exit No. 25 Gummersbach/Wiehl** and follow the signs to **Gummersbach-Zentrum** as described above.
- From Dortmund: Autobahn **A45** towards Frankfurt am Main. **Exit No. 16 Meinerzhagen/Gummersbach**, turn right onto the **B54** towards Gummersbach (approx. 20 km). In Gummersbach, follow the signs to **Gummersbach-Zentrum**. Turn onto Moltkestraße. The Eugen-Haas-Halle is located on the right-hand side.
- Parking: **Free** parking is available directly at the Eugen-Haas-Halle.
- Additional public parking spaces are available nearby, e.g. in the Forumsplatz parking garage or the Karlstraße parking deck. (approx. 5-7 minutes walking distance).
